- A portion of the tuition costs may be receiptable as a donation for tax purposes.
- To receive the early payment discount, tuition must be paid, in full, on or before the first day of school.
- Tuition fees cover only a portion of our operating costs so families are encouraged to support the school with their time and financial donations.
- Tuition must be paid in full by the end of the school year.
- Tuition does not include fees for sports team fees, extracurricular activities, etc.
- Gym uniforms are required for grades 5-10.
- These rates assume students are funded by the Ministry of Education. Such funding requires proof of Saskatchewan residency and legal immigration status.
- Tuition rates are set and reviewed annually by the SSCE Board.

FINANCIAL ASSISTANCE
SCS is pleased to offer financial assistance to qualifying families who would otherwise be unable to attend because of financial hardship. Awards of financial assistance are based on an analysis conducted by Apple Financial Services (www.applefinancialservices.ca) of a family's ability to contribute towards educational expenses.
Apple Financial Services charges a fee per family to perform the financial analysis. SCS will provide a tuition credit to those families who choose to enroll their child(ren), regardless of the outcome of the financial assistance application process.
